Groundbreaking for Kyle Crossing Medical Building Highlights the Influences on Modern, Multi-Specialty Facilities

AUSTIN, TX (June 14, 2011) —Hardin Construction Company's June 17th groundbreaking for the \$3.5 million Kyle Crossing Medical Office Building in Kyle, Texas, highlights how modern outpatient centers must balance many factors, from serving community needs and creating operational efficiencies to meeting the growing expectations of patients and medical practitioners.

The Kyle Crossing project—owned by Austin-based Onair Development, which focuses on medical office development throughout the U.S.—includes a 41,355-square-foot building skin and shell with glass curtainwall system and a steel-structure porte-cochere, as well as an 88,800-square-foot, 197-space adjacent parking lot.

“This will be the first truly off-campus multi-specialty facility serving Kyle, one of the fastest growing areas in Texas,” said Onair Development owner Kerry Angus.

Kyle Crossing is the third project—and the second multi-specialty medical facility—awarded recently to Hardin Construction by Onair Development.
